## CARROLL COUNTY SCHOOLS ANNUAL CONTRACT FOR NON-RESIDENT STUDENTS

child \_\_\_\_\_ in Carroll County Schools is predicated on the following conditions – all of which  
PRINT student name – one student per form

are applicable throughout the school year:

- A) Payment of a non-refundable out-of-district tuition fee as established by the Superintendent annually shall be paid in full before school begins at a date established by the Superintendent or upon enrollment in the child's school. Tuition for the 2017-2018 school year is \$350 per family per school year.
- B) If I/We move into the Carroll County School attendance area, the tuition fee is not refundable in whole or in part.
- C) The school system and local schools have the authority to verify addresses and actual domicile residence of any student.
- D) Transportation of non-resident students to and from school shall not be the responsibility of Carroll County Schools. Non-resident students may not ride the school bus to and from school. Furthermore, non-resident students may not catch a school bus or be dropped off at a school bus stop for the purpose of the system providing transportation.
- E) Continued enrollment of a non-resident student shall be determined and reviewed regularly based upon the following criteria:
  - 1. Consistent and punctual attendance with no excessive unexcused absenteeism, tardiness to school or checkouts during the school day.
  - 2. Satisfactory discipline record.
  - 3. Maintaining a "C" average or higher in each and all classes or as designated by principal.
  - 4. Satisfactory academic performance on standardized assessments, report cards, and/or other academic measurements.
  - 5. Student must remain current with all fees and charges incurred during the school year.
  - 6. Parent/guardian must maintain a cooperative relationship between the home and school.
- F) Any non-resident student who is registered in Carroll County Schools under false information is subject to immediate withdrawal and shall forfeit his/her tuition fee.
- G) Students must be domiciled with legal, custodial parent or guardian.
- H) Carroll County Schools reserves the right to reduce non-resident enrollment at any time.

**Note:** The above information is subject to verification through investigation. O.C.G.A. 16-10-20 states "a person who knowingly and willfully falsifies, conceals, or covers up by any trick, scheme, or device a material fact; makes a false, fictitious, or fraudulent statement or representation; or makes or uses any false writing or document, knowing the same to contain any false, fictitious, or fraudulent statement or entry...shall, upon conviction thereof, be punished by a fine of not more than \$1,000.00 or by imprisonment for not less than one nor more than five years, or both."
