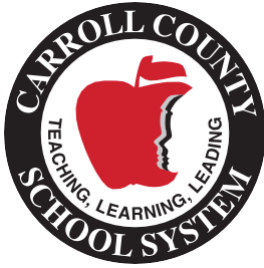

Statement of Legal Residence

If the family is living in a household with someone else, a Statement of Legal Residence form is required **AND** must be notarized. This form must be completed by the enrolling parent/guardian **AND** the homeowner/lessor. Enrolling parent/guardian should complete the section entitled "Affidavit of Parent/Guardian" (statements 1-4). The homeowner/lessor should complete the section entitled "Certification of Residence Owner/Lessor." Proof of residence must be provided in the name of the person completing this section of the form. This form will be required to be renewed each subsequent school year at the beginning of the year.
